**REGISTRATION AGREEMENT**

In acceptance of my child as a PFDC participant, I hereby agree to meet the financial requirements as stated by Pompositticut Farm Day Camp, Inc. I acknowledge the registration and administrative fee per child, per program are required with each registration. Once my child is enrolled, the registration and administrative fees are "non-refundable" and are "not transferable" between sessions or programs. Written notice of cancellation is required. Additionally there is a \$100 surcharge for all forms, fees and/or registrations submitted after May 1, 2012. No refund will be made for absence, withdrawal, dismissal, inclement weather, or any foreseen disaster whether natural or man made. There is a \$25.00 fee for checks returned by the bank with replacement payments accepted by certified bank check or cash only. No camper may begin his/her session until the tuition is paid in full, including finance charges which apply to "all late payments". The directors reserve the right to dismiss a camper when, in their judgement, the camper's behavior interferes with the rights and safety of others, with no refund offered.

**CAMPER INTERNET AGREEMENT:** It is important to the management and staff here at PFDC to maintain a code of conduct that promotes an emotionally and physically safe environment for all.
